Our Terms of Business include the following 2 options for payment (for attended funerals only). If you have any concerns about how you will meet the cost of the funeral arrangements you have made with us please speak to us as soon as possible, so that we can help and advise you.

Option 1: A prompt payment discount of £95

Payment in full (including third party charges) at least 5 working days before the funeral takes place and

receive a discount of £95.00 on our fees.

Please Note: If you are submitting our invoice to a bank or solicitor for payment, please ensure that they settle our invoice within the

timeframe noted above. Our prompt payment discount applies only to invoices settled in full prior to the funeral taking

place, otherwise our full professional service fees will be charged.

Option 2: Deposit payment of 40% of the total cost of the funeral

Deposit to be paid at least 5 working days before the funeral takes place. The remaining 60% to be paid in full

within 28 days of receipt of our invoice (after which interest charges will apply – see note below).

Please Note: If the total cost of third party charges exceeds 40% of the cost of the funeral, you will be asked to pay the higher amount.

If you do not make payment to us by the due date, we will charge you interest on the overdue sum at the rate of 4% per

month and any associated debt recovery costs where applicable. Please ask for further details.

Please note: For unattended funerals, we require payment in full prior to the cremation taking place

Payment: We accept payment by debit card, credit card, bank transfer (BACS), cash or certified cheque payments

Non-Payment: When making arrangements with us, your Funeral Director will ask you to confirm which option for payment you would

prefer and you will be required to sign our Client Agreement, accepting responsibility for the payment of our fees. If you do not make payment to us by the due date, we will charge you interest on the overdue sum at the rate of 4% per month and any associated debt recovery costs where applicable. Interest will accrue on a daily basis from the due date for

payment until the actual date of payment of the overdue sum.
